Tech Stack Review

Fully Vertically Integrated

- Usually, three systems
 - 1. POS
 - 2. Manufacturing/ERP
 - 3. Accounting

May be up to three integrations

- POS system → accounting system
- Manufacturing system ← → accounting system
- Manufacturing system ← → POS system

- ✓ Web-based data entry
- ✓ Budget workflow
- ✓ Built-in comments & line items
- ✓ Dynamic forecasting & modeling



Corporate Performance Management (CPM) Tool?


CPM is a process and methodology that provides an integrated approach to business planning, budgeting and forecasting for finance, sales, marketing, operations and HR.

- Includes forecasting, budgeting and planning functions
- Owned by the Finance function at an organization
- Allows for quick what-if analysis and scenario planning
- Ability to do variance analysis to understand the impact of changes version over version
- Easy access to a single source of truth with realtime results
