Bill Pay Screen

- View payment method for vendors

Recall a Submitted Bill

- Approver is notified the bill was recalled
- Bill moves back to draft state for updates prior to resubmitting

Vendor Approvals

- Improved CSV import files
- Reroute vendors through the approval process when updated through CSV import

GENERAL LEDGER

Other enhancements

- Adjustments cannot be entered in locked periods
 - When locking a closed statutory period, financial information **cannot be changed** with adjustments
 - Generate financial reports with assurance, confident that the data will remain consistent
- Control how far into the future you allow posting
 - Limited the number of **unlocked fiscal years** open
 - Prevent **future posting** outside of the current fiscal period

- Allow and do not show warning
- Allow and show warning

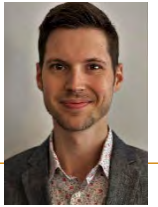

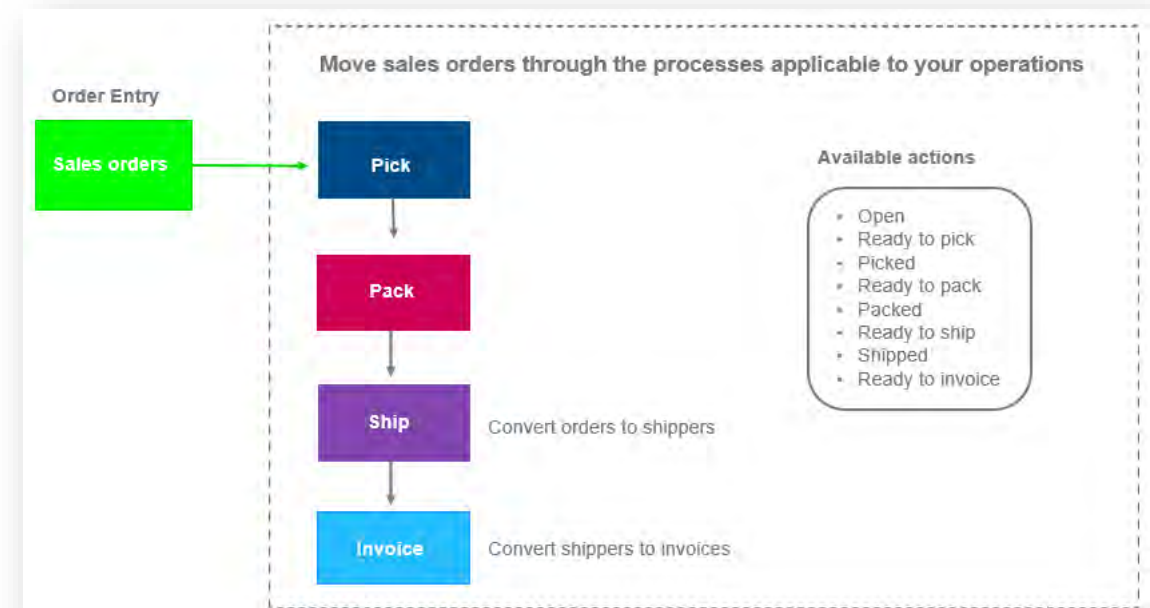

- It enhances the experience for the Warehouse team to utilize the tools to track and ship sales orders in a timely fashion
 - Provides **pick** and **pack** lists making their workflow more efficient and reduction in cost
 - Intacct will **reserve** and **allocate** quantities so the quantities cannot be used elsewhere

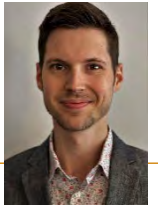
Commit quantities during Order Entry
