Sage Intacct Planning

- Dashboards
- Inputs
- Models



Dashboards

- Create multiple graphic representations of your budget
- Easily switch between the different dashboards and filter the data as needed
- Personalize different dashboards for the various departments and groups in your company
- Create and add relevant widgets to each dashboard

Inputs

- See your Profit & Loss, Balance Sheet and Statistical accounts from the Inputs
 - **Main:** See all the GL accounts that are linked to each budget line in your budget tree
 - **Model:** View models/calculations for Department trips, Cost of Revenue, or Revenue
 - Begin with a model from the library or create a custom model for your needs
 - **Tables:** See your budget tree structure in a table and filter the table by accounts

Models

- Create calculations with various fixed assumptions
- Models can easily be added to budgets
 - Changes to Models directly impact the budget lines to which they are assigned
- Fixed Assumptions can be used throughout the system for calculations

Reporting

- **Compare budget(s) using Sheets tab:**
 - **Actuals**
 - **Forecasts**
 - **Scenarios**

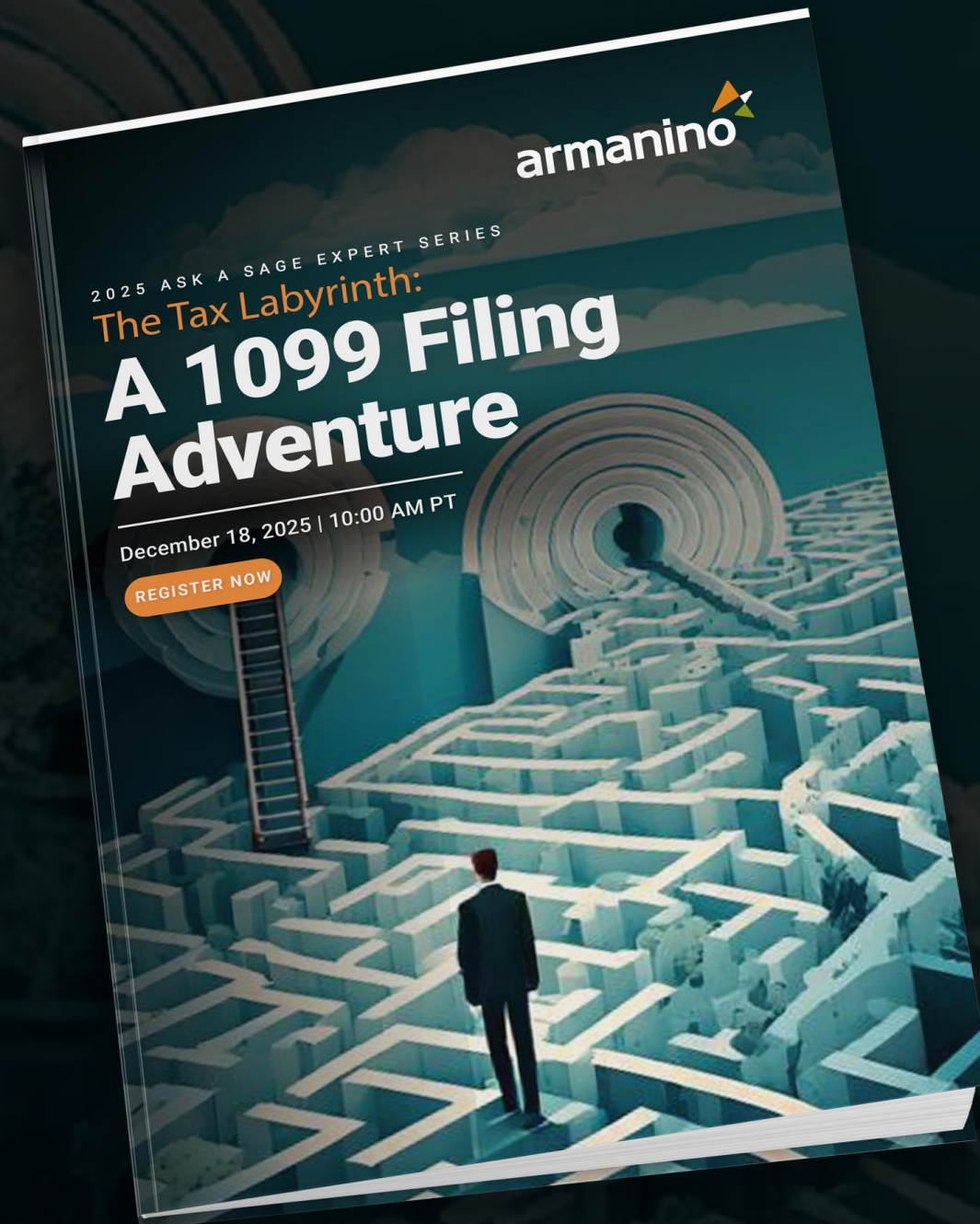
